

How to play

Rules of Play

- a) Entry is open to all Alberta Health Services staff, volunteers, and general public.
- b) Must be a current resident of Alberta and over 18 years of age.
- c) This is a 50/50 lottery (50 percent of cash goes to the winner, 50 percent is collected by the CRH Foundation).
- d) Purchase price of entry is \$5. No refunds will be given.
- e) There are a maximum of 100,000 tickets sold.
- f) In the event a winning ticket stub has more than one name on it, the CRH Foundation shall award the prize to only one of the individuals identified on the ticket. The Foundation and the AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
- g) A minimum of ten tickets need to be sold before requesting a draw date extension or cancelling the raffle through Alberta Gaming, Liquor and Cannabis Commission.
- h) Persons under the age of 18 years are not eligible to enter. Ticket sellers will be advised that purchasers may not write the name of someone under the age of 18 on the ticket.
- i) One winner is drawn in the Chinook Regional Hospital main atrium at 960 19 St. S., Lethbridge at 10 a.m. every second Wednesday starting April 13th, 2022, running to March 29th, 2023. If a draw date falls on a statutory holiday the draw will be made on the business day immediately following.
- j) Entry deadline is 9am on the day of the draw.
- k) All winners are notified in person or by telephone and their name will be posted at the CRH Foundation, and by email to all AHS South Zone employees.
- l) Prizes are paid by cheque and will be sent to the winner via mail two weeks after the draw date.
- m) Winner has up to one year to claim their prize.
- n) If a prize has not been picked up one year after the draw date the CRH Foundation will write the Alberta Gaming, Liquor and Cannabis Commission asking permission to revert the prize back to the CRH Foundation and the proceeds to be spent on currently approved Use of Proceeds.
- o) In the case of power failure, the draw will be conducted as soon as power is restored.
