## Rules of Play

- Entry is open to all Alberta Health Services staff, volunteers, and general public. Regulations prohibit the following persons and their immediate families residing in the same household from purchasing a ticket and being eligible to win: Raffle Administrators, Foundation staff and board of directors of Chinook Regional Hospital Foundation, and members of licensed gaming suppliers providing services to Chinook 50/50 Lottery.
- All purchasers must be a minimum of 18 years of age and physically be in the Province of Alberta at the time of purchase.
- This is a 50/50 lottery so the prize per draw is 50 percent of the tickets sold during that period.
- Purchase price of entry is 1 ticket/\$5, 4 tickets/\$15 or 6 tickets/\$25. Tickets are non-refundable once draws commence. Ticket purchases are not tax deductible. Prizes are tax-exempt. There is a total of 216,600 tickets sold.
- In the event a winning ticket stub has more than one name on it, the CRH Foundation shall award the prize to only one of the individuals identified on the ticket. The Foundation and the AGLC are not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.
- A minimum of ten tickets needs to be sold per pay period before requesting a draw date extension or cancelling the raffle through Alberta Gaming, Liquor and Cannabis Commission.
- Persons under the age of 18 years are not eligible to enter. Ticket sellers will be advised that purchasers may not write the name of someone under the age of 18 on the ticket.
- One winner is drawn using a RNG (random number generator) provided by Ascend Fundraising Solutions, in the Chinook Regional Hospital at 960 19 St. S., Lethbridge at 10 a.m. every second Wednesday starting April 9th, 2025, running to March 25th, 2026. If a draw date falls on a statutory holiday the draw will be made on the business day immediately following.
- In the event of a power failure the draw will be made on the business day immediately following.

- j) Entry deadline is 9am on the day of the draw and it re-opens at 11am for the next draw.
- k) All winners are notified in person or by telephone and their name will be posted on the chinook5050.ca website and by email to all AHS South Zone employees.
- l) The winner must provide his/her name, address, and phone number with picture identification for validation and send it to 5050@crhfoundation.ca. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided. All prizes will be delivered to the winner or sent via registered trackable mail service should in person pick up not be an option. If the winner cannot provide photo ID, then the winning proceeds will be held until such identification can be provided. The winning ticket holder has 3 months to claim their prize from the date of the draw. Unclaimed prizes will be reported, and a charitable allocation will be approved by AGLC
- m) Prizes are paid by cheque and will be sent to the winner via mail two weeks after the draw date.
- n) If a prize has not been picked up in 3 months after the draw date the CRH Foundation will write the Alberta Gaming, Liquor and Cannabis Commission asking permission to revert the prize back to the CRH Foundation and the proceeds to be spent on currently approved Use of Proceeds.
- o) The winner acknowledges and hereby irrevocably and in perpetuity release the right for CRHF, and/or their designees to use and/or publish the Winner's first name and first initial of the last name, city of residence, photographs or other likenesses, pictures, portraits, video, voice, testimonials, and/or statements made by the Winner regarding the raffle or otherwise worldwide and in perpetuity for any and all purposes, including, but not limited to, advertising, publicity, trade and/or promotion in any and all forms of media, now known or hereafter devised, including, but not limited to, print, TV, radio, electronic, cable, social media outlets or World Wide Web, without further limitation, restriction, compensation, notice, review, or approval
